## Reception of Holy Communion

For Catholics: As Catholics, we fully participate in the celebration of the Eucharist when we receive Holy Communion. We are encouraged to receive Communion devoutly and frequently. In order to be properly disposed to receive Communion, participants should not be conscious of grave sin and normally should have fasted for one hour. A person who is conscious of grave sin is not to receive the Body and Blood of the Lord without sacramental confession except for a grave reason where there is no opportunity of confession. In this case, the person is to be mindful of the obligation to make an act of perfect contrition, including the intention of confessing as soon as possible. (Code of Canon Law, Canon 916). A frequent reception of the sacrament of Penance is encouraged for all.

For Other Christians: We welcome all Christians to this celebration of the Eucharist as our brothers and sisters. We pray that our common Baptism and the action of the Holy Spirit in this Eucharist will draw us to one another and begin to dispel the sad divisions that separate us. We pray that these will lessen and finally disappear, in keeping with Christ's prayer for us "that they all may be one" (John 17.21).

Members of the Orthodox Churches, the Assyrian Church of the East, and the Polish National Catholic Church are urged to respect the discipline of their own churches. According to the Roman Catholic discipline, the Code of Canon Law does not object to the reception of Holy Communion by Christians of these churches. (Canon 844§3).

Canon law provides Eucharistic sharing by other Christians who do not have full communion with the Catholic Church only when the diocesan bishop deems there is an exceptional circumstance and the following conditions are present the other Christian on their own asksfor the sacrament, they manifest a Catholicfaith in the sacrament, are properly disposed and cannot approach a minister of their own community (Canon 844§4).

For non-Christians: We also welcome to this celebration those who do not share our faith in Jesus Christ. We have high regard for their traditions, friendship, and join them in promoting unity among all peoples. It is our joy to unite with them in praying for the peace and unity of the human family while respecting our common traditions, which do not include Eucharist sharing.

For all not receiving Communion: All who are not receiving Holy Communion are invited to express their prayerful desire for unity with God and with one another by approaching the altar at communion time with their hands crossed over their hearts. The minister will pray for this unity at the front of the Cathedral with all those in the communion line who have their hands crossed over their hearts.

Honorable Lazorence "Larry" Fames Gist passed away peacefully on October 19, 2019 in Beaumont, Texas at the age of 78 , surrounded by his family.

He was born to Genevieve Montz and George Mally Gist in Port Arthur, Texas on June 7, 1941. He attended Bishop Byrne High School in Port Arthur and later graduated from the University of Notre Dame and the University of Texas at Austin Law School. Following law school, he served as Assistant Criminal District Attorney of Jefferson County and Assistant State's Attorney before the Texas Court of Criminal Appeals. In 1974, he became the youngest State District Judge to be elected in Texas at the age of 34 . He spent the remainder of his career as a Criminal District Judge, serving in the last twenty years as full time Senior Criminal District Judge in the Jefferson County Drug Impact Court.

Judge Gist was certified in both Criminal and Appellate Law and served in many leadership roles over the course of his career including Chairman of the Judicial Advisory Council of the Texas Department of Criminal Justice as well as of the Community Corrections Committee following his appointment by Governor Rick Perry as a Member of the Texas Board of Criminal Justice. He was also an Adjunct Professor of Criminal Law for over twenty years at South Texas College of Law in Houston, and served as the Director of the International Comparative Criminal Law Course for over twenty-seven years. Through this program he organized and lead groups of attorneys and judges around the world yearly to study their judicial systems.

He was wholly dedicated to serving the community and received many honors and awards for his achievements. In 1994, the first State jail in Texas, the Larry Gist State Jail, was named in his honor. In 2014 he received the State Bar of Texas Judicial Lifetime Achievement Award, being the only trial court judge to receive this highest honor.

Judge Gist served as a mentor and role model in both the classroom and in the practice of law and will be remembered and missed by many. His greatest legacy is found in those in the community who turned their lives around after being given a second chance.

He loved his practice but also equally valued his time with family and friends. He was a master storyteller, creature of habit and avid fan of Notre Dame football. Whether it be over a quick trip to England, a Wednesday night at the Laine's, a Friday night dinner at Damian's in Houston, or a Sunday lunch in Beaumont with his family, he never failed to entertain with his playbook of colorful jokes and stories.

He is preceded in death by his parents and nephew Brian Sorensen.

He is survived by his sons, Lawrence "Lance" James Gist and Ryan Temple Gist; daughter, Malorie Gist Leman and husband Thomas; and grandchildren, Caitlin and Jamie Gist and Carolina, Mally and Lila Leman. He is also survived by his sister, Jackie Jarzambek and husband Don, and his niece and nephews, Shawn Sullivan, Maura Sorensen and Morgan Sullivan and their spouses.
