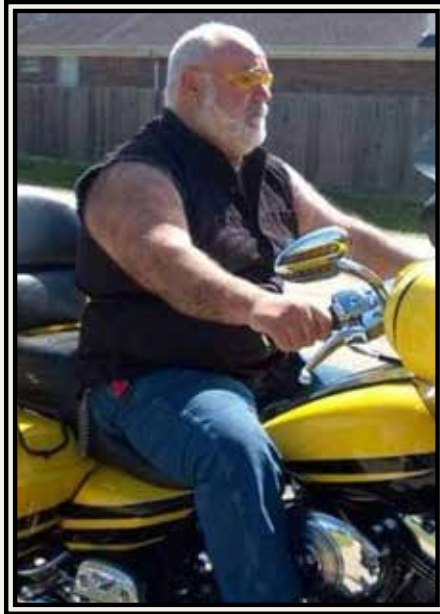

OUR HISTORY

Alexander Broussard was born in 1861 on Taylor's Bayou, south of Beaumont, to Sevenne and Belzire Broussard. The Broussards moved to southeast Texas in the 1840s and established large ranching operations in Jefferson and Chambers Counties. Alexander's keen sense of livestock led him to open A. Broussard Livery Stable, and in the late 1800s, began providing undertaking services. In the early 1890s, he opened the first funeral parlor in southeast Texas and began a five-generation tradition of caring and service to the area.

That first wood framed parlor on Fannin Street in downtown Beaumont was replaced in 1903 by a large brick facility which still stands today. In 1928, the family firm moved to a stately home at the corner of Calder Avenue and Forest Street. In 1958, they moved to one of their present locations in a quiet neighborhood on McFaddin Avenue at Fourth Street in Beaumont. As more families have relied on their care, there are now several facilities that serve much of southeast Texas.

Alex Broussard was succeeded in the family business by his son, Dale. In the 1950s, the founder's grandsons, Alex Broussard and James Broussard joined the firm. By the early 1980s, the family vocation was in its fourth generation when Jim Broussard and Tom Broussard joined the company. Today, Blue Broussard and Jayme Broussard Toepfich, great-great-grandchildren of the founder, have now established the fifth generation of Broussard's service to southeast Texas families.

The family's leadership and desire for ethics in their profession led them to be a part of the fledgling Texas Funeral Directors Association in the early 1900s, and to carry some of the first licenses of the Texas Undertakers and Embalmers. In 1950, Broussard's was invited to membership in to what is now Selected Independent Funeral Homes, an organization whose membership is based on the highest standards of excellence in their industry. In 1998, their family firm was presented the inaugural Torch Award for Marketplace Ethics by the Better Business Bureau of Southeast Texas, and their firm was also selected as an Outstanding Texas Family Business by Baylor University.

Professional recognitions for the Broussard family and staff include two Governor Appointments and Presidencies of the Texas Funeral Service Commission; Board Members and Officers, including two Presidencies of Selected Independent Funeral Homes, Texas Funeral Directors Association, and the Southeast Texas Funeral Directors Association, including two Funeral Director of the Year accolades; the Federal Emergency Management Agency's Regional Disaster Mortuary Team appreciation for outstanding performance immediately following the Oklahoma City bombing; and numerous awards commending service to the area following Hurricane Rita.



Our Code of Good Practice

Revisions effective July 1, 2009

As funeral directors, our calling imposes upon us special responsibilities to those we serve and to the public at large. An important obligation is to provide information so that everyone can make knowledgeable decisions about funeral and cremation services.

In accepting our responsibilities, and as a condition of our affiliation with Selected Independent Funeral Homes, we affirm the following standards of good practice and hereby pledge:

- To provide the public with information about funeral and cremation services, including prices, functions and the responsibilities of funeral directors
- To make services available in as wide a range of price categories as necessary to meet the needs of all segments of our community, and to affirmatively extend to everyone the right to inspect and freely consider them all
- To quote conspicuously in writing the charge for every arrangement offered, and to clearly identify the services, facilities, equipment and merchandise included in such quotations
- To adhere to the highest standard of conduct in all aspects of business
- To afford an ongoing opportunity to all persons to discuss or arrange funerals in advance
- To ensure that pre-need contracts fully disclose those items which are guaranteed and those which are nonguaranteed, in terms that are clear and easy to understand
- To manage prepaid funds responsibly, ensuring that promises are honored and expectations are met, within the letter and spirit of the law
- To make no representation, written or oral, which may be false or misleading and to apply a standard of honesty in all dealings
- To furnish each family, at the time arrangements are made, with a written memorandum of charges and to make no additional charge without their approval
- To respect all faiths, creeds and customs, and to give full effect to the role of the clergy/celebrant
- To maintain qualified and competent staff, appropriate facilities and suitable equipment required for comprehensive funeral and cremation services
- To assure those we serve the right of personal choice in making service arrangements

We pledge to conduct ourselves at all times in a manner deserving of the public trust, and to provide a copy of this Code of Good Practice to the families we serve.
